Subject of the Disclosure

Risks and Impact of the COVID-19 on the business operations of PHR.

Background/Description of the Disclosure

On 12 March 2020, the Philippine national government raised the coronavirus disease 2019 (COVID-19) alert level to “Code Red Sublevel-2” as the number of infected persons in the Philippines continues to climb.

The PHR management team notes that there are safety measures being implemented or to be implemented by the national or local government that may affect its on-going projects, such as:

1. The imposition of localized “community quarantines” in their respective jurisdictions (i.e. Lapulapu City, Cebu or Panglao, Bohol) if there is evidence of COVID-19 transmission;
2. The suspension of land, domestic air, and domestic sea travel to and from Metro Manila from 15 March 2020 to 14 April 2020, subject to continuous monitoring and review;
3. The limitation of foreign travel, especially for foreigners traveling from countries with localized COVID-19 transmissions;
4. The suspension of work at various government offices (except for skeletal work); and
5. The encouragement to the private sector to implement work-from-home arrangements.

The above measures may affect the (1) construction and development of the Emerald Bay Resort and Casino at Mactan, Cebu (owned by its subsidiary, Lapulapu Leisure, Inc.); and (2) operations of the Donatela Hotel, a boutique hotel located at Panglao, Bohol (owned by its subsidiary, Donatela Hotel Panglao Corp.):

PHR’s management team is constantly monitoring press releases and coordinating with contacts at various government offices to better understand the implications of COVID-19. It is finalizing a business continuity plan in order to mitigate and minimize the its negative effects.

Nevertheless, the construction and development of the Emerald Bay in Mactan, Cebu will keep moving forward. There might be some delays in the construction possibly on account of availability of construction workers, construction supplies, and other circumstances beyond the control of PHR. If there are significant unexpected changes in the construction timeline, we shall apprise the public immediately as an update to this disclosure.

The operations of the Donatela Hotel may be significantly affected in furtherance of a “community quarantine.” In any event, the management is keeping the expenses at minimum and is executing general cleaning and small in-house renovations while occupants are expected to be low at this time.

Nevertheless, the offices for PHR remain operational and functional.
