Issuance of new shares pursuant to the Placement and Subscription Transaction of PH Resorts Group Holdings Inc. ("PHR" or the "Company")

Background/Description of the Disclosure

As disclosed in the PSE disclosures with report number C05756-2021 and C05777-2021, the Company entered into a Placing and Subscription Transaction which involves the offer and sale of 352,441,000 common shares ("Offer Shares") of PHR. The Offer Shares was offered by Udenna Corporation, via private placement, to certain Qualified Buyers (as defined under the Securities Regulation Code). Simultaneous with such placement, Udenna Corporation subscribed to 352,441,000 common shares ("Subscription Shares") of the Company. Both the Offer Shares and the Subscription Shares were priced at Php 1.70 per share.

Thus, pursuant to the Placing and Subscription Transaction, the Company issued an additional 352,441,000 common shares. The Company shall apply for the listing of the Subscription Shares with the PSE as soon as practicable.

In addition, the change in public float stated below also takes into account a separate share transaction executed by Udenna Corporation on 23 August 2021. Information on this share transaction is provided by the appropriate SEC Form 23-B of Udenna Corporation.
